Summary of agreement

Rainmaker Ranch Labradoodles (RRL) and the above mentioned approved breeder have agreed to the exchange of \$2800 USD plus all AI collection and shipping fees in exchange for two shipments of fresh chilled semen from Tegan Park Casper owned by RRL to the approved breeder as detailed below.

CONDITIONS OF STUD SERVICE

1. A total of two collections are offered with fresh chilled semen which can be delivered overnight to the bitch's vet for AI OR the dam and dam owner may travel to FL and our ICSB facility will proceed with a direct transfer of semen during ovulation. All collection and certifications will be handled by a licensed veterinarian or an AKC certified collection facility or equal. Included in that service will be a sperm count and motility test to assure viability.
2. At the signing of this contract XYZ and RRL will exchange the deposit and all appropriate pedigree's and health documentation on RRL's Tegan Park Casper as well as the planned dam owned by the aforementioned breeder.
3. Stud fee will be paid via a \$800USD deposit and \$2000USD due prior to the first shipment of fresh chilled semen.
4. The aforementioned breeder pays for all collection services and delivery fee, approximately \$200 to \$250 per collection and delivery of fresh chilled (generally requires 2 collections) price depends on delivery service used and collection facility costs. Fees and services are paid directly to the collection facility. RRL can arrange for same day shipment and Sunday shipment if necessary at the dam owners additional expense.
5. Two live puppies will constitute a litter. If no litter is produced from this breeding, RRL will offer a repeat breeding to the same bitch at no additional stud service fee. Bitch owner will be responsible for repeat collection and shipment fees.
6. XYZ will pay all costs associated with AI and all other reproductive services. It is required that XYZ will have progesterone tests performed on their dog to help determine the best time for insemination by a qualified vet.
7. RRL assumes no responsibility for injury, illness or death associated with AI.
8. XYZ will provide RRL a pedigree of the selected dam, a copy of the most recent CERF certificate or PRA-DNA certificate, and OFA score of good or better or PennHip score of .55 or better for the dam prior to shipment of semen. Current planned use of RRL's TP Casper stud service is for _____. No other bitch will be used for RRL's TP Casper stud services without written permission of RRL and all the appropriate paperwork from XYZ. If XYZ fails to comply with this provision, he/she shall pay RRL \$25,000.00 in liquidated damages for the harm done to the reputation of the stud dog, the stud dog owner and the breed in general.
9. XYZ will NOT transfer ownership of any pup resulting from this breeding to any person or organization whose intent is to re-sell, trade or give away the puppy or use it in laboratory experiments. If XYZ fails to comply with this provision, he/she shall pay to the stud dog owner \$25,000.00 in liquidated damages for the harm done to the reputation of the stud dog, the stud dog owner and the breed in general.
10. XYZ agrees to have all puppies de-sexed at 7 or 8 weeks of age except for those being sold or traded as potential breeding stock to another breeder. Information regarding pups being placed with other breeders must be provided to RRL, including the name of the breeder, kennel name, and program information. RRL has the right to refuse the sale of any direct prodigy of Casper and XYZ's to any breeder and XYZ must have written permission of all intact dogs to be kept or sold from the resulting litter. If XYZ fails to comply with this provision, he/she shall pay RRL \$25,000.00 in liquidated damages for the harm done to the reputation of the stud dog, the stud dog owner and the breed in general.
